

Due to the increment of the total of foreign workers in Indonesia that reached 111,818 in January 2023, the Indonesian government created new regulations to facilitate foreigners through the enactment of Omnibus Law in lieu of the Job Creation Law (UU Cipta Kerja) Article 144 (1) of 2020 which allows foreigners to have Strata title ownership rights of non-landed property ie. Condominiums, Apartments in Indonesia. The purpose of this event is to socialize the related provision and its implementing regulation to the relevant stakeholders in Indonesia, namely foreign workers, Property Developer companies, Apartments/Condominium legal officers, mix marriage community, in house counsels, lawyers and any other interested parties.
