**Immigration License Stay Services in the New Normal Phase - Visa Application Updates**

The Directorate General of Immigration of the Republic of Indonesia has announced the new services of immigration is opening for the New Normal Phase as published on the Circular Letter No. IMI-GR.01.01-1102 Year 2020 on July 10th 2020 concerning on Immigration Licensing Services in the New Normal Phase. The purpose of the issuance of this circular is to complete the Circular of the Director General of Immigration Number IMI-GR.01.01-2325 Year 2020 Regarding Temporary Prohibitions of Foreigners Entering the Territory of the Republic of Indonesia and the Circular of the Director General of Immigration Number IMI-GR.01.01-2493 Year 2020 About Expansion of the Director General of Immigration Circular Number IMI-GR.01.01-2325 of 2020 Regarding Temporary Prohibitions of Foreigners Entering the Territory of the Republic of Indonesia Regarding Procedures for Granting Entry Permits for ITAS/ITAP/IMK/Visa Approval Holders Applicable.

Based on this Circular Letter, as per **July 13th 2020** all of the visas mentioned above or within the circular letter must be extended due to the implementation of new immigration licensing services for new normal phase. Further, for Visa on Arrival (VOA)/ VKSK, based on Permenkumham No. 11 Year 2020 regarding Temporary Prohibition of Foreigners Entering the State of The Republic of Indonesia stipulated on 31st March 2020 that expatriates / foreigners outside Indonesia who wants to visit Indonesia is still prohibited. For expatriates or foreigners inside Indonesia who have acquired the emergency stay permit (ITKT) earlier stipulated on April 2nd 2020 can extend their VOA/VKSK.
