**INFORMATION****Minister of Energy Resources and Minerals (ESDM) No.182 K/10/MEM/2020 about the Market Price Index of Biodiesel Fuel from Mixed Vegetable Oil Into Fuel**

The Minister of Energy and Mineral Resources (ESDM) has issued Decree No. 182 K/10/MEM/2020. This regulation will regulate the Market Price Index (HIP) of Biodiesel Fuel from Vegetable (BBN) for the type of biodiesel blended into fuel oil (BBM). The HIP already existing since October 1, 2020. The establishment of Ministerial Decrees No. 182 K/10/MEM/2020 is because the government will continue the mandatory biodiesel fuel oil program and readjust the Market Price Index (HIP) formula for Biodiesel fuel mixed into fuel.

Based on the plan, the Government through the Ministry of Energy and Mineral Resources needs to amend and re-enact two old regulations;

- The Minister of Energy and Mineral Resources Decree No. 350 K/12/DJE/2018 which regulates the amount of conversion of CPO to biodiesel, the maximum amount of transportation costs, and the consignment fee for Floating Storage Balikpapan, and
- The Minister of Energy and Mineral Resources No. 135 K/12/MEM/2020 which regulates HIP Biodiesel during the Covid-19 emergency.

The eight important points in the Ministerial Decree No. 182 K/10/MEM/2020 are:

1. The establishment of a new HIP biodiesel formula that takes into account the price of palm oil (CPO) in Belawan and Dumai the previous month plus the conversion of CPO to Biodiesel at US\$ 85 per Metric Ton (MT). The conversion factor used is 870 kg / m<sup>3</sup>, plus the freight cost per area with the maximum amount.
2. The Biodiesel HIP applies to general and certain fuels.
3. The Ministry will determine the amount of HIP every month.
4. For the delivery point for floating storage or shore terminals in Balikpapan, the HIP formula must be added to the reconciliation result of the maximum unit cost according to the Minister of Energy and Mineral Resources Decree No. 182 K/10/MEM/2020.
5. The maximum amount of transportation costs also applies to biodiesel business entities with more than one supply point (factory location).
6. Biodiesel business entities that distribute through other supply points can also use HIP provided that the transportation cost is based on the maximum amount of freight cost which is the lowest value between other supply points and the factory location.
7. If the transportation costs of which the delivery point and supply point are not listed in the Ministerial Decree No. 182 K/10/MEM/2020, then the maximum amount of transportation costs is calculated if there is a change in the Ministerial Decree.
8. Business entities that have distributed biodiesel whose transportation costs have been listed in the Ministerial Decree No. 350 K/12/DJE/2016, the transportation costs refer to the Minister of Energy and Mineral Resources No. 148 K/10/DJE/2019

The minimum transportation costs (IDR / Liter) apply in 32 provinces covering 136 points of delivery and 436 points of supply. The range of transportation costs in each province is as follows:

Moreover, the maximum amount of floating storage or Balikpapan shore terminal with the delivery point for Floating Storage Balikpapan and Shore Terminal Balikpapan is IDR 202 / liter each.
