The Extension of Enforcement of Restrictions on Community Activities (PPKM) Java-Bali to January 17th, 2022

According to the press conference held by Secretariat of the President of the Republic of Indonesia on January 3rd, 2022, the Coordinating Minister for Maritime Affairs and Investment, Luhut B. Pandjaitan announced about the extension regarding the regulations implementation of the Emergency Community Activity Restriction (PPKM) in Java-Bali. The government decided to extend the PPKM Java-Bali effective **from January 4th until January 17th 2022**.

The extension is affirmed in the Instruction of the Minister of Home Affairs (Inmendagri) No. 1 Year 2022 on the Enactment of Restrictions on Community Activities Level 3, Level 2 and Level 1 Corona Virus Disease 2019 in Java and Bali. Meanwhile, The Ministry of Health, Budi Gunadi Sadikin targets the Covid-19 booster vaccination program or injecting the third dose of vaccine to adults will begin on January 12th, 2022.

There are several adjustments on the regulations of PPKM in Java-Bali, include:

1. The implementation of activities in the non-essential sector is carried out 50% of Work From Office (WFO) for employees that has been vaccinated and must use the PeduliLindungi application. While essential sector carried out 75% of WFO.
2. The implementation of non-quarantine hospitality has a maximum capacity of 50% of visitors and must use the PeduliLindungi application for screening.
3. The implementation of shopping activities is limited to operating hours until 21:00 local time with a maximum visitor capacity of 75% and must use the PeduliLindungi application.
4. The implementation of activities in shopping centers / malls / trading centers is opened with a maximum capacity of 50% until 21:00 local time.
5. The implementation of activities in places of worship is limited to a maximum of 75% capacity by implementing the health protocols. Meanwhile, public facilities are allowed to be opened with a maximum capacity of 25% with health protocols.
6. Public transportation, mass transit, online taxis, rental vehicles, and aircraft are allowed with a maximum capacity of 100% with the strict health protocols.

As emphasized before, the government still urges people to remain compliant with health protocols even though the current positive case of Covid-19 continue to decrease by always implementing 3M (wear a mask, washing hands, keep the distance and avoid the crowd) and 3T (testing, tracing, and treatment).
