The Extension of Enforcement of Restrictions on Community Activities (PPKM) Java-Bali to February 14th, 2022

According to the press conference held by Secretariat of the President of the Republic of Indonesia on Monday, February 7th, 2022, the Coordinating Minister for Maritime Affairs and Investment, Luhut B. Pandjaitan announced about the extension regarding the regulations of the implementation of Emergency Community Activity Restriction (PPKM) in Java-Bali. The government decided to extend the PPKM Java- Bali effective **from February 8th until February 14th 2022**. The extension is affirmed in the Instruction of the Minister of Home Affairs (Inmendagri) No. 9 Year 2022 on the Enactment of Restrictions on Community Activities Level 3, Level 2 and Level 1 Corona Virus Disease 2019 in Java and Bali. In his announcement, Minister Luhut stated that a number of agglomeration areas would have level 3 statuses in the extension of the implementation of restrictions on community activities (PPKM). The areas in question are Greater Jakarta, DIY, Bali, and Greater Bandung.

Therefore, there are several adjustment on the regulations of PPKM in Java-Bali, include:

- 1. The implementation of activities in the non-essential sector is applied to:
 - Level 3: a maximum of 25% Work From Office (WFO) for employees that has been vaccinated and must use the PeduliLindungi application.
 - Level 2: a maximum of 50% Work From Office (WFO) for employees that has been vaccinated and must use the PeduliLindungi application.
 - Level 1: a maximum of 75% Work From Office (WFO) for employees that has been vaccinated and must use the PeduliLindungi application.

As DKI Jakarta is in the Level 3,hence Jakarta is implementing 25% WFO for non-essential sectors.

- 2. The implementation of non-quarantine hospitality has a maximum capacity of 50 percent of visitors and must use the PeduliLindungi application for screening.
- 3. The implementation of shopping activities is limited to operating hours until 21:00 local time with a maximum visitor capacity of 60 percent and must use the PeduliLindungi application.
- 4. The implementation of activities in shopping centers / malls / trading centers is opened with a maximum capacity of 60% until 21:00 local time.
- 5. The implementation of activities in places of worship is limited to a maximum of 50% capacity by implementing health protocols. Meanwhile, public facilities are allowed to be opened with a maximum capacity of 25% with health protocols.
- 6. Public transportation, mass transit, online taxis, rental vehicles, and aircraft are allowed with a maximum capacity of 100% with strict health protocols.

As emphasized before, the government still urges people to remain compliant with health protocols though the current positive cases of Covid-19 continue to decrease by always implementing 3M (wear a mask, washing hands, keep the distance and avoid the crowd) and 3T (testing, tracing, and treatment).
