**INFORMATION****Instructions for Implementing Foreign Travel With Air Transportation During The Corona Virus Disease Pandemic 2019 (Covid-19)**

The Ministry of Transportation (Kemenhub) has revised the rules regarding the entrance of foreign tourists through Circular Letter (SE) No. 12 Year 2022 concerning Guidelines for the Implementation of Overseas Travel by Air Transportation during the Covid-19 Pandemic Period. The spokesman for the Ministry of Transportation Adita Irawati stated that Circular Letter No. 12 Year 2022 was needed so that it could be a reference for airport operators, airlines, and other stakeholders, in the context of operations for handling Overseas Travelers (PPLN). Further, International travelers including tourist can enter through the airport gates:

- Soekarno-Hatta in Jakarta
- Ngurah Rai in Bali
- Hang Nadim Batam
- Haji Fisabilillah in Tanjung Pinang

As previously, in the Circular Letter No 11 Year 2022, it was only through I Gusti Ngurah Rai Airport (Bali), Hang Nadim Airport (Batam), and Raja Haji Fisabilillah Airport (Tanjung Pinang). For the foreigner, there are several requirements as follow:

- Foreigners need to follow the visa rules as set out in the Minister of Law and Human Rights Regulation No. 34 Year 2021 concerning the Granting of Immigration Visas and Residence Permits in the Period of Handling the Spread of Covid-19 and National Economic Recovery.
- Foreigners enter according to a bilateral agreement scheme, such as the travel corridor arrangement (TCA) between the Indonesian Government and the United Arab Emirates, China, South Korea, and Singapore.
- Foreigners get special consideration or permission in writing from the ministry or agency.
- Foreigners who are already in Indonesia and will travel, both domestically and internationally, are required to vaccinate through a program or mutual cooperation scheme in accordance with applicable laws and regulations.
- Foreigners are required to use the PeduliLindungi application as a condition for international travel to enter Indonesian territory.
- Foreigners must show proof of ownership of health insurance with a minimum coverage value of USD \$25000 which includes financing for handling Covid-19.
- Foreigners are required to show proof of booking confirmation and payment for accommodation from the accommodation provider while staying in Indonesia.

Furthermore, both Indonesian citizens and foreigners must comply with the health protocol provisions set by the government, including showing a vaccine card or certificate at least 14 days before departure.
