## Circular Letter No. 8 Year 2022 about Bubble System Mechanism Health Protocol in Bali in the Time of Covid-19 Pandemic

The COVID-19 Response Acceleration Task Force has issued Circular Letter No. 8 Year 2022 about Bubble System Mechanism Health Protocol in Bali in the Time of the Corona Virus Disease Pandemic 2019 (Covid-19). This Circular Letter is effective from 23 February 2022 until a later specified time. This regulation is applied to both Indonesian citizens (WNI) and foreign nationals (WNA) travelers who will carry out activities in Bali.

There are several points highlighted in this regulation:

1. The perpetrators of the bubble system can enter the bubble system area in Bali with the following mechanism:
  - Direct travel through the Foreign Travelers (PPLN) entry point or foreign travel agents to the bubble system area in Bali;
  - Transit through the foreign traveler entry point and then continue domestic travel to the bubble system area in Bali;
  - or domestic travel by air, land, or sea to the bubble system area in Bali.
2. The entry points for Indonesian citizens/foreigners to enter the bubble system area in Bali are I Gusti Ngurah Rai International Airport in Denpasar or Tanjung Benoa Harbor.
3. Upon arrival at the entry point, the Indonesian citizens (WNI) perpetrators of the bubble system in Bali, except for support staff, must comply with the following conditions/requirements:
  - Have downloaded the PeduliLindungi application and filled out the Indonesian International e-HAC;
  - Show the card/certificate (physical or digital) has received the second dose of Covid-19 vaccine at least 14 (fourteen) days before departure written in English other than the language of the country/region of origin of arrival, and verified on the website of the Ministry of Health or e-HAC International Indonesia;
  - Show negative results through RT-PCR test in the country/region of origin whose samples are taken within a maximum period of 2 x 24 hours before departure and are attached at the time of the health examination or Indonesian International e-HAC;
  - Show proof of official registration documents or involvement in the Bubble System Activity (KSB) series, such as proof of confirmation of booking and payment for tour packages, proof of involvement of conference/meeting delegates, or other evidence of involvement in the KSB series;
4. Meanwhile, perpetrators of the bubble system in Bali who are foreigners (WNA), must meet the following requirements:
  - Show a visit visa or other appropriate entry permit provisions of laws and regulations; and
  - Show proof of ownership of health insurance with value coverage determined by the organizer or managers and includes financing for handling COVID-19 and medical evacuation to a referral hospital.
  - And undergo a body temperature check and RT-PCR examination upon arrival at the PPLN entry point;
5. If the RT-PCR result upon arrival in the entry points is negative, then the perpetrators of the bubble system in Bali continue with:
  - For foreign travelers who make transit trips, they must do the following: centralized quarantine according to duration and mechanism as stipulated in the COVID-19 Response Acceleration Task Force Circular Letter No. 7 Year 2022 that applies to, then continue the journey to the bubble system area in Bali; or
  - Follow the pick-up and drop-off procedures directly to the destination location according to the bubble group that is set by the organizer or manager.
6. If the RT-PCR result upon arrival in the entry points is positive, then the perpetrators of the bubble system in Bali then follow up with the following conditions:
  - For positive cases of COVID-19 without symptoms or experiencing symptoms mild, isolation or treatment is carried out in accommodation separate isolation from the bubble area; or
  - For positive cases of COVID-19 with moderate or symptomatic symptoms severe, isolated or treated at a referral hospital;
  - All costs of isolation/treatment for Indonesian citizens are borne by the government. While for foreigners it is borne independently

The purpose of this Circular is to implement health protocols against the mechanism of the bubble system in Bali and to monitor, control, and evaluate the mechanism of the bubble system in Bali in order to prevent an increase in the transmission of COVID-19.
