**INFORMATION****The Extension of Enforcement of Restrictions on Community Activities (PPKM) Java-Bali to March 7th, 2022**

In accordance with the Instruction of the Minister of Home Affairs (Inmendagri) No. 13 Year 2022 concerning the Implementation of Restrictions to Community Activities Level 4, Level 3, and Level 2 Corona Virus Disease 2019 In Java and Bali, the government has again implemented the Java-Bali community activity restrictions (PPKM) starting from 1st to 7th March 2022.

There are four highlighted changes in the Inmendagri No 13 Year 2022: First change is, PPKM Level 4 is applied to 7 new regions: Cilegon West Java; Cirebon West Java; Sukabumi West Java; Magelang, Central of Java; Tegal, Central of Java; Salatiga Central of Java and Madiun, East Java. Secondly, PPKM Level 1 is no longer enforced. The third, PPKM status of Level 2 has decreased from 25 regions to 13 regions. Lastly, the number of regions with PPKM status of Level 3 has increased from 99 regions to 108 regions.

There are several adjustments on the regulation of PPKM in Java-Bali, include:

1. The implementation of activities in the non-essential sector is applied to:
  - Level 4: with a maximum of 25% of Work From Office (WFO) for employees who have been vaccinated and are required to use the PeduliLindungi application at the entrance and exit of the workplace;
  - Level 3: with a maximum of 50% of WFO for employees who have been vaccinated and are required to use the PeduliLindungi application at the entrance and exit of the workplace; and
  - Level 2: with a maximum of 75% of WFO for employees who have been vaccinated and are required to use the PeduliLindungi application at the entrance and exit of the workplace.

As DKI Jakarta is in Level 3 of PPKM, hence Jakarta is implementing 50% WFO for non-essential sectors.
2. Export-oriented industries can operate 75% staff for each shift in production facilities/factories, and 25% office administration services by implementing strict health protocols
3. Non-quarantine hotels can operate by screening using the PeduliLindungi application with a capacity of 50%, and 25% for the use of ballrooms/fitness facilities/meeting rooms;
4. Restaurants/restaurants, cafes, supermarkets, hypermarkets, traditional markets, grocery stores, supermarkets that sell daily necessities, to activities in shopping centers can operate until 21.00 with a maximum visitor capacity of 50%. Especially for supermarkets, hypermarkets and shopping centers, it is necessary to carry out screening using the PeduliLindungi application, and only visitors with the green category may be allowed to enter; Meanwhile, restaurants/restaurants and cafes with operating hours from 18.00 to 00.00 can operate with a maximum capacity of 25%;
5. People's markets that sell non-daily necessities can operate with a maximum capacity 50% and operating hours until 20:00.

To prevent the additional cases of Covid-19, the government urges people to remain compliant with health protocols though the current positive cases of Covid-19 continue to decrease by always implementing 3M (wear a mask, washing hands, keep the distance and avoid the crowd) and 3T (testing, tracing, and treatment).
