Update Visa Rate to Enter Indonesia, Effective from April 16th, 2022

On February 15th 2022, the Government regulates the new tariffs for immigration services through Minister of Finance Regulation (PMK) Number 9/PMK.02/2022 concerning Types and Tariffs for Types of Non-Tax State Revenue (PNBP) on Immigration Services Applicable to the Ministry of Law and Indonesian Human Rights. This regulation is effective 60 days from its promulgation, which is April 16th 2022.

Previously, the tariff for immigration services was regulated in Government Regulation (PP) No. 28 Year 2019. This new PMK regulates tariffs for new services that have not been accommodated in PP 28 Year 2019 as well as changes to several service rates. A 60-day non-tourist visit visa was previously cost USD 50. However, the price has increased to IDR 2 million. For international tourist visa now costs IDR 1.5 million. This has included a visa processing fee that was previously charged IDR 200,000. A visit stay permit obtained through this type of visa can be extended for another 60 days for a fee of IDR 2 million.

This update is supported by the official statement of the Director General of Immigration at the Law and Human Rights Ministry, Widodo Eka Tjahjana on April 17th 2022. He stated that there is a new immigration service that is mandated by the Job Creation Act and the tariff must be accommodated. In terms of visas, the only thing that changes is the visit visa rate. Other service charges, meanwhile, are still awaiting applicable legal regulations and are not yet accessible. Because the COVID-19 outbreak in Indonesia has not been declared over, the nation is still enforcing restrictive visas. The significant difference in this new Minister of Finance Regulation is stated in the one-way visit visa fare.

According to the regulation, the following are the details of the visa rates starting from April 16th, 2022:

1. Single-entry visit visa for a maximum of 60 days: IDR.2 million per person
2. Single-entry visit visa for a maximum of 180 Days: IDR.6 million per person
3. Single-entry visit visa for a maximum of 60 days: IDR.1.5 million per person
4. Multiple-entry visa: IDR.3 million per person;
5. VoA on arrival (VoA): IDR. 500,000 per person;
6. Limited stay visa: US\$ 150 per application;
7. Residence visa for a second home: IDR. 3 million
8. Limited stay visa for a second home for dependents (husband, wife, child and parents): IDR. 2 million per person;
9. Visit stay permit valid for a maximum period of 60 days: IDR. 2 million per application
10. Visit stay permit valid for a maximum of 180 days for pre-investment: IDR. 6 million per application
11. Extension of a visit permit with a validity period of 30 days: Rp500,000 per application;
12. Limited stay permit for a second home with a maximum stay of five years: Rp12 million per application
13. Limited stay permits for a second home for dependents (husband, wife, child and parents) with a maximum stay of five years: IDR. 3.5 million per person;
14. Permanent residence permits for a second home with a maximum stay of five years: IDR. 15 million per application
15. Permanent residence permits for a second home for dependents (husband, wife, child and parents) with a maximum stay of five years: IDR. 5 million per person
16. Permanent residence permits working for a second home for an indefinite period: IDR. 30 million per application
17. Permanent residence permits for a second home for dependents (husband, wife, child and parents) for an unlimited period of time: IDR. 15 million per person
18. Re-entry permit valid for five years specifically in special economic zones (SEZ): IDR. 3.25 million per application;
19. Re-entry permit valid for a maximum of five years in the context of a second home: IDR. 6 million per application
20. Re-entry permit valid for a maximum of five years in the context of a second home for followers (husband, wife, child and parents): IDR. 1.5 million per person.
