Updates of the Extension of Enforcement of Restrictions on Community Activities (PPKM) Java-Bali to 3rd October 2022

The expansion of the Community Activity Restrictions (PPKM) for the Java-Bali area was carried out once again. Following up on the President of the Republic of Indonesia's directive, the Ministry of Home Affairs has issued an Instruction to the Minister of Home Affairs (Inmendagri) No. 42 Year 2022 to implement the Level 3, Level 2, and Level 1 Corona Virus Disease 2019 (COVID-19) Community Activity Restrictions (PPKM) in Java and Bali, in accordance with the criteria for the level of the pandemic situation based on the assessment, and to complete the implementation of PPKM and optimizes the COVID-19 Handling Post at the Village and Sub-District levels, from 6th September to 3rd October 2022.

The government has reintroduced the Java-Bali community activity restrictions (PPKM), with a few tweaks to the number of locations that implementing PPKM levels 1. There is no change regarding the operating time of public places and facilities, which is until 22.00 local time. As a result, various changes have been made to the PPKM rules in Java-Bali, including:

- 1. The implementation of activities in the non-essential sector is applied to:
 - Level 1: a maximum of 100% Work from Office (WFO) for employees that has been vaccinated and must use the PeduliLindungi application.
- 1. The implementation of non-quarantine hospitality has a maximum capacity of 100% of visitors and must use the PeduliLindungi application for screening.
- 2. The implementation of shopping activities is limited to operating hours until 22:00 local time with a maximum visitor capacity of 100% and must use the PeduliLindungi application.
- 3. The implementation of activities in shopping centres / malls / trading centres are opened with a maximum capacity of 100% until 22:00 local time.
- 4. The implementation of activities in places of worship are limited to a maximum of 100% capacity by implementing health protocols. Meanwhile, public facilities are allowed to be opened with a maximum capacity of 100% with health protocols.
- 5. Public transportation, mass transit, online taxis, rental vehicles, and aircraft are allowed with a maximum capacity of 100% with strict health protocols.

As emphasized before, the government still urges people to remain compliant with health protocols though the current positive cases of Covid-19 continue to decrease by always implementing 3M (wear a mask, washing hands, keep the distance and avoid the crowd) and 3T (testing, tracing, and treatment).
