Updates on the Trial of Reopening the Multiple-Entry Visitor Visa for Foreigners in Indonesia

We would like to inform you of the updates about the trial of reopening the Multiple-Entry Visitor Visa based on the Directorate General of Immigration Press Release. This policy is effective from 22 November 2022.

Multiple-Entry Visit Visa is a type of visit visa that allows foreigners to travel in and out of the Indonesian territory within 1 (one) year. Every time a foreigner enters Indonesia, they are granted a residence permit for 60 (sixty) days. This trial is carried out to provide immigration convenience for business people with high mobility which will have a significant impact on Indonesia's economic recovery.

Foreigners who will apply for the Multiple-Entry Visit Visa must have a guarantor in the form of a legal entity or company in Indonesia. A Multiple-Entry Visit Visa applications are made by the guarantor, either online through the <u>visa-online.imigration.go.id</u> website or through Indonesian Representatives abroad.

Foreigners holding Multiple-Entry Visit Visas must also complete several other requirements, namely:

- 1. A valid nationality passport and still valid for at least 18 (eighteen) months;
- 2. Letter of guarantee from the Guarantor except for visits in the context of tourism;
- 3. Proof of having living expenses for himself and/or his family while in the Indonesian Territory in the form of a checking account, savings book, or time deposit for the last 3 (three) months owned by a Foreigner or guarantor with an amount of at least USD 2000 (two thousand US dollars) or equivalent;
- 4. A return ticket or a connecting ticket to continue the journey to another country except for the crew of the transport equipment who will stop by to join the ship and continue the journey to another country; and
- 5. Recent photograph taken at least the last 3 (three) months with a white background.

In addition, there are additional requirements during the COVID-19 pandemic, as follows:

- 1. A statement of willingness to comply with all applicable health protocols in Indonesia;
- 2. Evidence of having received the full dose of COVID-19 vaccine;
- 3. Proof of ownership of health insurance/travel insurance that includes health financing, and/or a statement letter willing to pay independently if affected by COVID-19 while in the Indonesian territory.

The rate for the Multiple-Entry Visit Visa is IDR 3.000.000 per person/year, with these foreigners can go back and forth to Indonesia without needing to extend their residence permit. Foreigners holding Multiple-Entry Visit Visa can carry out activities, including conducting business talks, tours, government duties, purchasing goods, meetings, humanitarian reasons, and transit.
