The Official Enactment of Second-Home Visa for Foreigners in Indonesia on 21 December 2022

The Minister of Law and Human Rights, Yasonna H Laoly officially enacted the Second Home Visa policy in Indonesia by the release of the Circular Letter of the Director General of Immigration Number IMI-0820.GR.01.01 Year 2022 on 21 December 2022. The inauguration of the policy targeting global investors and billionaires was carried out during the Handover of the Pura Wira Ksatria Immigration Patrol Boat and the Launching of the Second Home Visa at Lagoi Bintan, Riau Archipelago.

Second-Home Visa is a visa intended for foreigners who come to Indonesia such as investors, travelers, and elderly/retirement tourists. Holders of a Second-Home Visa can also apply for the same visa for their children, husband/wife, or parents as followers. This visa will be valid for 5 - 10 years.

Foreigners can apply for a second-home visa through the Online Visa Approval application with some required documents such as:

- 1. Copy of passport that is valid for a minimum of 36 (thirty-six) months
- 2. Proof of Funds in foreigners' or sponsors' bank account (must be placed in Indonesian government-owned banks) of at least IDR 2.000.000.000 (two billion rupiahs) or equivalent
- 3. Recent color photograph (4 cm x 6 cm) with a white background
- 4. Curriculum vitae

Sponsors or foreign nationals can also apply for a visa on the official website of the Directorate General of Immigration at <a href="https://www.imigrasi.go.id">www.imigrasi.go.id</a> or directly on the Online Visa Approval application. A foreigner or sponsor applies for a Second-Home Visa for followers through an application by attaching the following:

- 1. Copy of passport that is valid for a minimum of 36 (thirty-six) months
- 2. Recent color photograph (4 cm x 6 cm) with a white background
- 3. A valid Second-Home Visa or Second Home Temporary Stay Permit of their husband, wife, children or parents
- 4. Evidence of having a family relationship with a holder of a Second-Home Visa or Second-Home Stay Permit by showing:
  - Marriage certificate for husband/wife who holds a Second-Home Visa or Stay Permit, or
  - Birth certificate or family card stating that the foreigner is the parent or child of the holder of a Second-Home Visa or Stay Permit, translated into Indonesian by a born translator, except if the document is already in English.

The fee for making a Second-Home Visa is IDR 3.000.000 per person. The processing time for a visitor visa is 4 (four) working days after the applicant completes the immigration fee payment. Sponsors or applicants can check their visas in the Online Visa Approval application account and email.
