Restrictions on Imported Goods Carried by Passengers Traveling from Abroad starting from 10 March 2024

The Minister of Trade, Zulkifli Hasan issued the Ministry of Trade Regulation (Permendag) No. 36 Year 2023 concerning Import Policies and Regulations on 11 December 2023 and is **effective on 10 March 2024**. This regulation aims to limit the entry and simplify the monitoring of imported goods.

Following up on the issuance of the regulation, the Directorate General of Customs and Excise (Direktorat Jenderal Bea dan Cukai/DJBC) has officially implemented restrictions on the amount of luggage carried by passengers traveling from abroad. With the implementation of this regulation, restrictions will be imposed on goods brought in from abroad which are controlled by Customs and Excise.

This regulation is applied to **all passengers traveling abroad**, including Indonesian Migrant Workers (Pekerja Migran Indonesia/PMI) who will return to their hometowns.

The number of restricted items and their limitations are as follows:

1. Animals and animal products with a maximum of 5 kg and not exceeding USD 1.500 per passenger or crew member
2. Rice, corn, sugar, garlic, and horticultural products with a maximum of 5 kg and not exceeding USD 1.500 per passenger or transport crew
3. Mutiara with a maximum value on Free on Board/FOB of USD 1.500
4. Fishery products with a maximum of 25 kg per shipment
5. Handphones, tablets, and laptops with a maximum of 2 units per person within 1 year of arrival
6. Toys with a maximum value FOB of USD 1.500
7. Bags with a maximum of 2 pieces per person
8. Footwear with a maximum of 2 pieces per person
9. Electronics with a maximum of 5 units and maximum value FOB at USD 1.500 per person
10. Bicycles and tricycles with a maximum of 2 units per person
11. Alcoholic drinks with a maximum of 1 litre per person
12. Downstream plastic with a maximum value FOB of USD 1.500
13. Other finished textile goods with a maximum of 5 pieces per person

Furthermore, it is stated that Soekarno Hatta International Airport Customs and Excise will charge an additional import fee for goods to passengers who are carrying more than the specified amount.
