## The Big Scale Social Limitation "PSBB" Guidelines of the restrictions to accelerating in handling the Corona Virus Disease 2019

PSBB (Pembatasan Sosial Berskala Besar) in an area is determined by the Minister of Health of the Republic Indonesia based on the request of the heads regional governments e.g Governors, Regents, Mayors and the Chairpersons of the Task Force for the Acceleration of Handling COVID-19.

**The Procedures to Declare PSBB**

1. The heads of regional government submits a proposal to the Minister with the required data (an increase in the number of cases according to time, distribution of cases according to time, and local transmission events).
2. A direct request from the Chairperson of the Implementing Task Force for the Acceleration of Handling COVID-19 to determine PSBB in certain areas, based on an evaluation of the criteria that must be met.
3. Requests by the head regional government can be submitted individually or collectively.
4. The head of Regent and Mayor has to consult and referral to their Governor for the declare letter to PSBB.
5. If the cross-provincial Regional Government agrees to collectively implement PSBB, the submission of the application shall be made through the Chairperson of the Task Force for the Acceleration of Handling COVID-19.

**Criteria that Must be met for PSBB:**

1. A significant increase in the number of cases and or deaths and rapid spread of cases in other regions in a certain period of time, and evidence of local transmission.
2. A significant increase in the number of cases and or deaths discovered from observation of the epidemiological curve of cases and or deaths.
3. The rate of disease spreading by daily and weekly basis observation.

**PSBB Stipulation Includes:**

1. School and work from home
2. Restrictions on religious activities
3. Limitation of activities in public places and facilities
4. Limitation of social and cultural activities
5. Limitation of transportation modes
6. Limitation of activities related to defense and security aspects.

**Facilities and Services that are Still Running during PSBB:**

1. Supermarkets, minimarkets, traditional markets, pharmacy stores, groceries supply, important goods, fuel oil, gas, and energy.
2. Health care and other health services facilities.
3. Public places or facilities to fulfill the basic needs of residents including sports activities.

**Modes of Transportation that May Operate during PSBB:**

1. Passenger transportation; planes, ships, trains, highway (public or private transportation) services continue to operate with restrictions on the number of passengers.
2. Transportation for fire services, law and order services, and emergency services.
3. Logistic transportation for basic needs and essential goods
4. Train, airlines and sea transportations for cargo, aid and evacuation, and organizations operational including national army operational.

The Governor of DKI Jakarta announced the implementation of **14 days'** period of PSBB start **per April 10th 2020** for the private vehicles and public transportation with limitation of the number of passengers.

PSBB will implemented by the provincial government of West Java with regions **Bogor, Depok, Tangerang, Bekasi, and Bandung** start on **Wednesday, April 15<sup>th</sup> 2020**.

The provincial government office opens with normal activities and other offices should close during the PSBB period except there are 10 business sectors remain opens with normal activities.

**The 10 Business Sectors remain opens:**

1. Health sector; hospitals, clinics and the health industry and producers (soaps, disinfectant, etc).
2. Food & Beverages sector; retails and groceries products.
3. Energy sector; water, gas, electricity, and gas stations.
4. Communication sector; services and media.
5. Construction sector
6. Financial & Banking sectors, including the capital market.
7. Hospitality sectors; hotels.
8. Logistics sector, products and materials distribution.
9. Daily necessities sector; foods stalls and stores.
10. Strategic industrial sector in the Capital Region (DKI Jakarta).
