



On January 11th 2020 the Presidential Secretariat have streamed the conference on the issuance of the National Disaster Management Authority (BNPB) Circular Letter No. 4 Year 2020, which regulating the travel ban for foreigners from January 1st until January 14th 2021, the Coordinating Minister for Economic Affairs, Mr. Airlangga Hartarto stated that it will be extended for 2 weeks or from January 15th to January 28th, 2021. The Chairperson of the Committee for Handling Covid-19 and National Economic Recovery (KPC PEN) also emphasized the issue of enforcement restrictions on community activities from January 11th to January 25th, 2021.

The implementation of this activity restriction policy is in accordance to Law No. 6 Year 2018 concerning Health Quarantine and Government Regulation No. 21 Year 2020 on Large-Scale Social Restrictions (PSBB) about the government rearranges restrictions on activities to control the spread of COVID-19. The government has also issued the Minister of Domestic Affairs Instruction No. 01 Year 2021, which sets priority areas and regulates the imposition of restrictions on community activities that have the potential to cause Covid-19 transmission.

Further, the quarantine provisions for international passengers arriving in Indonesia are listed in the Addendum to Circular Letter No. 03 Year 2020 and No. 04 Year 2020. Domestic and International travelers who arrived in Indonesia must quarantine for 5 days at the specified location. There are 27 Hotels appointed for self-quarantine in Jakarta as follow:

Moreover, the quarantine provisions for international passengers arriving in Indonesia are listed in the Addendum to Circular Letter No. 03 Year 2020 and No. 04 Year 2020. Domestic and International travelers who arrived in Indonesia on December 28th – 31st 2020, must quarantine for 5 days at the specified location. Then, the next provision is listed in CL No. 04 Year 2020 which confirms the closure of the entry of foreigners from all countries to Indonesia on January 1st to January 14th, 2021; which recently extended until January 28th 2021 except for foreigners who meet the exclusion criteria in accordance with this circular, namely holders of diplomatic visas and official visas related to official visits of foreign officials at ministerial level and above; the holder of a diplomatic residence permit and an official residence permit; temporary stay permit (KITAS) and permanent stay permit (KITAP) holders.
