



The DKI Jakarta Provincial Government has again extended the Implementation of Micro-Based Community Activity Restrictions (PPKM) for the period of June 22th 2021 to July 5th 2021 under the DKI Jakarta Governor's Decree No. 796 Year 2021 concerning on the Micro-Based Community Activity Restrictions (PPKM) Extension.

As the Covid-19 cases are increasing which has reported 2.033.421 confirmed positive cases as per June 23rd 2021, the government has taken an extra step and has decided to tighten the implementation of restrictions on micro-scale community activities (PPKM). Based on the governor's decree, there are 11 sectors that are specifically regulated, including:

1. The Office Activities

The office activities at high risk of Covid-19 are required to implement the Work from Home (WFH) system for 75% employees. Only 25% of employees are allowed to work from the office (WFO). Meanwhile, the offices that are located outside the red zone are implementing both WFH and WFO.

2. Teaching and Learning Activities

Schools, colleges, or academies that are in the Covid-19 red zone are required to implement online teaching and learning activities. While, other zones teaching and learning activities should follow the rules that have been implemented by the Ministry of Education with the application of strict health protocols.

3. Essential Sector

Essential sectors such as the basic service industry, public utilities, basic community needs such as supermarkets and pharmacies could be able to run 100% by implementing strict health regulations and protocols.

4. Restaurant and Shopping Center

Restaurants, food stalls, cafes or shopping centers can only operate until 20.00. Visitors are limited to 25 percent of the total capacity of the venue or room. Instead, you can do delivery or take away services.

5. Construction Activities

Construction activities at the construction site or project site can operate 100% with strict health protocols.

6. Worship

All of red zone-located worship activities will be temporarily closed until the situation is declared safe. Meanwhile, outside the red zone, activities at worship place will follow the regulations of the Ministry of Religion and with the implementation of strict health protocols.

7. Activities in Public Areas, Cultural Arts and Social Activities, and Meetings and Seminars

All of the public areas, cultural social activities in the red zone area will temporarily be closed this includes tourism areas or recreational parks, gym and fitness center, museums, galleries, etc. Meanwhile the meetings and seminars should be conducted virtually or online. While outside the red zone area will be limited to 25% of the total site capacity along with the strict health protocols.

8. Public Transportation

The central government handed over the policy of restrictions on public transportation to local governments with stricter health protocols.
