Update List of Countries Subject to Visa On Arrival (VOA)

The Director General of Immigration released Circular Letter No. IMI-0076.GR.01.01 Year 2023 concerning the Electronic Visa on Arrival (E-VOA), Visa on Arrival (VOA), and Free Visit Visa Services to Support Sustainable Tourism during the 2019 Corona Virus Disease Pandemic on 27 February 2023.

In this regulation, Kenya and Rwanda were officially added to the list of countries subject to a Visit Visa on Arrival. Currently there are a total of 89 countries which are eligible to apply for VoA including:
