Update of List of Countries Subject on Visa on Arrival (VoA) to 92 Countries Based on Circular Letter IMI-0133.GR.01.01 Year 2023

The Director General of Immigration released Circular Letter IMI-0133.GR.01.01 Year 2023 concerning the Electronic Visa on Arrival (E-VOA), Visa on Arrival (VOAA), and Free Visit Visa Services to Support Sustainable Tourism and Facilitate Community Economic Development.

In this regulation, Panama, Guatemala, and Maccau are officially added to the list of countries subject to a Visit Visa on Arrival. Currently there are a total of 92 countries which are eligible to apply for VoA including:
