## Updates on the Temporary Suspension of Free Visit Visa in Indonesia

The Minister of Law and Human Rights issued Ministerial Decree No. M.HH-01.GR.01.07 Year 2023 concerning the Temporary Suspension of Free Visit Visa (Bebas Visa Kunjungan/BVK) for Countries, Governments of Special Administrative Regions of a Country, and Certain Entities. This regulation was issued as the government's response to address concerns of public safety and public health such as public order and disease spread. This regulation is effective from 9 July 2023 and will be announced accordingly.
