



As a follow-up to the previous Golden Visa publication, the Government of Indonesia through the Ministry of Finance released Regulation No. 82 Year 2023 concerning the Types and Rates of Non-Tax State Revenue Urgent Needs for Golden Visa Services applicable to the Ministry of Law and Human Rights. This regulation is effective from **30 August 2023**.

Previously, the visa tariff was referred to the Ministry of Finance Regulation No. 9/PMK.02/2022 concerning the Appendix Related to Types and Rates of Types of Immigration Services Non-Tax State Revenue Related to Second Homes. Currently, the Ministry of Finance Regulation No. 9/PMK.02/2022 is **revoked and replaced** with the Ministry of Finance Regulation No. 82 Year 2023.

The lists of rate fees to apply for application submission are as follows:

I. Visa

There are several types of visas with different fees as follows:

1. Visit Visa for Multiple Trips are divided into two different durations with the detail as below:
 - a. With duration maximum to 5 Years is IDR 10 million
 - b. With duration maximum to 10 Years is IDR 15 million
2. Limited Stay Visa is IDR 500.000
3. Certain Purposes Visa

There are several verification fees based on the categories:

- a. *Category I with the fee of IDR 1 million* subjected to visit purpose as below:
 - Art and culture;
 - government duties;
 - non-commercial sports;
 - comparative studies, short courses, and short training;
 - giving lectures or attending seminars;
 - conducting journalistic visits;
 - participating in international exhibitions;
 - attend meetings;
 - make purchases of goods;
 - join the Transport Equipment located in Indonesian Territory; and
 - film making.
- b. *Category II with the fee of IDR 2 million* subjected to visit purpose as below:
 - Carry out emergency and urgent work;
 - provide guidance, counseling, and training in the application and innovation of industrial technology to improve product quality and design industry as well as foreign marketing cooperation for Indonesia;
 - perform audits, production quality control, or inspection on company branches in Indonesia;
 - after-sales service
 - installing and repairing machines;
 - prospective foreign workers in a capability trial in work; and
 - pre-investment and apprenticeship

II. Immigration Permit

There are four types of permits with the detail as follow:

1. Limited Stay Permit are divided into two different durations with the detail as below:
 - a. With duration maximum to 5 years is IDR 7 million
 - b. With duration maximum to 10 years is IDR 12 million
 2. Permanent Residence Permit are divided into three different durations with the detail as below:
 - a. With duration maximum to 5 years is IDR 7 million
 - b. With duration maximum to 10 years is IDR 12 million
 - c. With duration of an unlimited period is IDR 15 million
 3. Re-entry Permit are divided into three different durations with the detail as below:
 - a. With duration maximum to 5 years is IDR 3.5 million
 - b. With duration maximum to 10 years is IDR 5 million
 - c. With duration maximum of unlimited validity period is IDR 8 million
- III. Permission to leave Indonesian territory and not return (Exit Permit Only) is IDR 100.000
- IV. Other Immigration Non-Tax Revenue (Penerimaan Negara Bukan Pajak/PNBP), for reporting changes in civil status and immigration status is IDR 500.000
